ABOUT THE DIRECTORY

The Uninsured Motorists Identification Directory (UMID) is provided by the New Jersey Office of the Insurance Fraud Prosecutor, Division of Criminal Justice, Department of Law and Public Safety. The Directory enables law enforcement officials to telephonically contact insurance companies for the purpose of confirming whether a driver who presents proof of insurance is, in fact, insured with the insurance company or other entity set forth on the insurance identification card.

The Directory is divided into two parts. Insurance companies and self-insured entities authorized to insure vehicles in New Jersey are listed alphabetically in Part A of the Directory. Part B of the Directory lists insurance companies and self-insured entities numerically by their MVC (formerly DMV) code numbers.

In some cases, the telephone number provided for a given insurance company is the general telephone number of a parent company with one or more subsidiaries or affiliated companies. As a result, it may not be readily apparent to the user of the Directory that the correct number has been reached. In those cases, it may be necessary for the user to specify, to the party contacted, the name of the company about which the user is calling.

Due to a variety of factors such as corporate restructuring, withdrawal from the New Jersey automobile insurance market and telephone number reassignments, it is anticipated that some of the information contained in this Directory will change prior to the issuance of the next updated edition. If a user of this Directory discovers that information pertaining to a particular insurance company or self-insured entity is no longer current, kindly contact the Law Enforcement Liaison in the New Jersey Office of the Insurance Fraud Prosecutor at (609) 896-8854, to ensure that the information is updated in the next edition of the Directory.
